



RENTAL INFORMATION

What is needed for vehicle pick-up?

When picking up the vehicle you need a valid credit card, identification card or passport and a valid

driver's license. The credit card needs to have enough available funds to cover the deposit amount. The height of the deposit (authorization) depends on the price of the rental, the vehicle type, and category, as well as the chosen coverage.

The credit card can be charged for any extra costs that can appear during the rental period.

For the authorization process, we accept all credit cards such as MasterCard, American Express (ACCEPTED ONLY IN ATHENS, THESSALONIKI, HERAKLION CHANIA, RHODES, MYKONOS), Visa Card. We do not accept prepaid or electron cards (Visa Electron, Maestro) for the authorization process.

The lessee must be the owner of the credit card

The rental can be paid with a credit card, pre-paid or electron cards.

Bear in mind that payment with a credit card may require your

pin code.

Driver's License

The client, as well as any additional drivers, need to be in possession of a valid driver's license for at

In case of a traffic accident, theft, engine breakdown or similar

Driver's licenses that are not printed in the Roman alphabet (Arabian, Japanese, Cyrillic) need to be accompanied by an international driver's license.

At vehicle pick-up please present a valid identification card or passport alongside a valid driver's license

Rental period, and grace period

Vehicles are rented daily. There is a 59-minute grace period, that is not charged. After 60 minutes, a whole day of usage is charged.

Changes in the reservation

Reservations can be changed up to 48 hours before the rental period

Reservation cancellation

Reservations can be canceled before the rental

In the case that the client did not pick up the reserved vehicle for some reason or did not pick it up in the agreed time, if CARWIZ is not informed CARWIZ extra charges can be applied

Age limitations

In Greece, the following minimum lessee age required, and driver's licensepossession are followed

- (a) 21 years old/2 years for vehicles in groups Mini, Economy, Compact, Intermediete, Standard
- (b) 23 years old/2 years for vehicles in groups Compact Elite, Sedan, Luxury, Full
- (c) The Young/Senior driver fee applies to drivers aged 21-23 and 74-78

General terms of coverage

At vehicle pick up it is important to choose some type of extra coverage, there are different coverage packages which are adjusted to your needs and abilities, from decreased damage excess to no excess at all.

Collision Damage Waiver limits the driver's responsibility for damages done to the vehicle. The customer is only responsible for the following amounts:

- 1000,00 € (MDMR, MBMR, MBAR, MDAR, ECMR, EDMR, EDAR, NTMR, NTAR)
- (b) 1300,00 € (CCMR, CDMR, CCAR, CDAR, CJMR, SWMR,IDMR, IDAR,
- (c) 1450,00 € (DDMR, CFMR, CFAR, CGMR, CGAR, IGMR, IGAR, IFMR,
- 1550,00 € (DDAR, JDMR, JDAR, SDMR, SDAR, SFAR, FVMR,) (d)
- 1700,00 € (CTAR, DTAR, FVAR, SVMR, LVMR, LVAR, PVMR) (e)
- 2200,00 € (JFDR, JFDD, SGAR, XDAD, XFDR, JFMR)

The damage done to the vehicle will be charged according to the repair price list available in our offices.

Passengers are covered in cases of disability or death to the amount stated in current insurance

Risk and user responsibility can be limited to accepting the following additions.

MCDW

Reduced excess amount reduces the damage excess to the following

- 500,00 € (MDMR, MBMR, MBAR, MDAR, ECMR, EDMR, ECAR, EDAR, NTMR, NTAR)
- 650,00 E (CCMR, CDMR, CCAR, CDAR, CJMR, SWMR, IDMR IDAR, IWAR)
- 725,00 € (DDMR, DDAR, CFMR, CFAR, CGMR, CGAR, IGMR, IGAR, IFMR, IFAR) (c)
- 775.00 € (IDAR, SDMR, SDAR, DTAR, SFAR, FVMR) (d)
- 850.00 € (CTAR, FVAR, SVMR, LVMR, LVAR, PVMR) (e)
- 1100.00 € (JEDR. JEDD. SGAR, XDAD. XEDR. JEMR)

Super Collision Damage Waiver (SCDW)

Is coverage that reduces responsibility to 0 in case of damage to the vehicle body.

The client is obliged to:

- (1.) keep the vehicle safe until the time it is picked up by the lessor
- (2.) take the names and addresses of every witness and participant
- (3.) call the police and procure their record except in the case of motor breakdown
- (4.) give a statement as soon as possible in the nearest office of the lessor
- (5.) In the case that the user does not procure a police report, all accepted coverages such as TP / CDW, MCDW or SCDW are considered invalid due to the client's failure to comply with the provisions of the rental agreement and general terms and conditions

Costs that are not covered by CARWIZ and cannot be covered by any additional coverage

- (1.) Loss or theft of luggage and or personal items from
- (2.) Parking tickets or fines, traffic violations and such
- (3.) Costs due to the wrong fuel type usage
- (4.) Expenses for lost, stolen or damaged car keys (5.) Expenses for lost, stolen or damaged car
- documents (6.) Expenses due to negligence -

empty battery

- (7.) Expenses due to damage to the car's interior
- (8.) Costs of lost equipment (spare tire, tire repair kit, bunker shelves, document etui.
- driver's manual) (9.) Expenses due to damage to additional equipment
- (10.) Expenses due to car misuse
- (11.) Expenses due to ignoring instruction for car maintenance stated in the cars service book
- (12.) Expenses to the vehicle under the influence of alcohol or drugs
- (13.) Costs of car extraction from inaccessible areas (e.g. extraction from mud due to traveling outside regular road infrastructure)
- (14.) Expenses incurred by using dirt roads (15.) Expenses incurred by car racing or cars participation in $% \left\{ 1,2,...,n\right\}$
- sport events (16.) Expenses due to overburdening the car with
- people or cargo
- (17.) Damage costs caused by a person not stated in the contract as the main or additional driver (18.) Costs created in cases when the main driver or additional driver stated in the rental contract
- does not have a valid driver's license or has a ban on driving motor vehicles (19.) Other: damaged windscreen wipers or locks, loss or theft of outside parts of the vehicle
- without a police record, damage costs incurred by usage of roof carriers or luggage on carriers, damage caused by improper handling of luggage and or putting cargo or luggage on the roof, hood etc., as well as expenses caused by ignoring sound and visual warnings of the

One-way vehicle rentals within Greece:

For the service of one-way vehicle rentals, the following fees are applied:

- (a) From Heraklion to Chania – 50,00 €
- From Heraklion to Souda port 50,00 € (b)
- From Chania to Heraklion 50.00 € (c)
- (d) From Chania to Souda port - 20.00 €
- From Souda port to Heraklion -50,00 € (e)
- From Souda port to Chania 20,00 € (f)
- From Athens to Piraeus port 35,00 € (g)
- (h) From Athens to Thessaloniki - 200.00 €
- (i) From Piraeus port to Athens airport - 35.00 €
- From Piraeus port to Athens downtown 20,00 €
- From Piraeus port to Thessaloniki 200,00 € (k)
- From Thessaloniki to Athens 200,00 € (1)
- (m) From Thessaloniki to Piraeus port - 200.00 €
- (n) From Kalamata to Patra - 223.20 €
- From Patra to Kalamata 223,20 €

All other one-ways are not allowed / in case of a drop-off at any location without prior permission additional fee will be applied!

Additional equipment and services

Fuel options

All vehicles are coming with a full tank and need to be returned with a full tank. If the client returns the vehicle with less fuel, he will be charged according to a valid price list. Refiling service will be applied.

Additional Driver

The fee for an additional driver is 6,20 € per day, max. per rental 71.68€

A child seat is a legal obligation and needs to be used for children up to 12 years of age and 135 cm of height, Choose the seat that best fits child age:

- (a) Baby seat (0-18 kg) 6,50€ per day (120.00 € max per rental)
- (b) Child seat (15-36 kg) 6,50€ per day (120,00 € max per rental)
- (c) Booster seat (children height up to 135 cm) 6.50€ per day (120,00 € max per rental)

If you decide to rent a navigation system with your vehicle, the fee of 8,00 € per day will apply, maximum 80,00 € per rental

Damage handling fee - administration fee

If the lessee does not have any additional coverage package, and vehicle damage occurs, alongside the damage itself, an additional fee of 50.00 € will be applied. Fee for processing traffic violation and parking fine – 40,00 €

In the case that the lessee has lost the car key, a minimum fee of 200,00 € and more (depends on a vehicle model) will be applied.

Lost documentation or registration plates
In the case of lost or stolen vehicle documentation/ registration plates, a fee of 350,00 € will be applied.

The police report is mandatory.

Vehicle Cleaning

In case the vehicle requires a special cleaning procedure after drop-ott (i.e. smell removal, animal hair, spillage of liquids), a minimum fee of 150.00 € will be charged

Don't smoke in vehicles

The penalty for smoking in the vehicle is 90,00 $\ensuremath{\varepsilon}.$
