



# RENTAL INFORMATION

## What is needed for vehicle pick-up?

When picking up the vehicle you need a valid credit card, identification card or passport and a valid

The credit card needs to have enough available funds to cover the deposit amount. The height of the deposit (authorization) depends on the price of the rental, the vehicle type, and category, as well as the chosen coverage.

The credit card can be charged for any extra costs that can appear during the rental period.

## Terms of payment

For the authorization process, we accept credit cards MasterCard, Visa Card.

For payment process, we accept MasterCard and Visa Card.

The lessee must be the owner of the credit card.

The rental can be paid with a credit card, pre-paid or electron cards, as well as cash

Bear in mind that payment with a credit card may require your

### Driver's License

The client, as well as any additional drivers, need to be in possession of a valid driver's license for at least one year.

Driver's licenses that are not printed in the Roman alphabet (Arabian, Japanese, Cyrillic) need to be accompanied by an international driver's license.

At vehicle pick-up please present a valid identification card or passport alongside a valid driver's license.

### Rental period, and grace period

Vehicles are rented daily. There is a 59-minute grace period, that is not charged. After 60 minutes, a whole day of usage is charged.

## Changes in the reservation

Reservations can be changed up to 48 hours before the rental period.

## Reservation cancellation

Reservations can be canceled before the rental

period.

The cancellation should be made online or in written form via e-mail to

In the case that the client did not pick up the reserved vehicle for some reason or did not pick it up in the agreed time, if CARWIZ is not informed CARWIZ extra charges can be applied

In Bosnia and Herzegovina, the following minimum lessee age required, and driver's license-possession are followed:

- (a) 21 years old/2 year for vehicles in Mini, Economy, Compact and Intermediate group categories
- (b) 25 years old/2 years for vehicles in groups Compact Elite, Sedan, Premium, Luxury
- (c) A young/senior drivers fee of 10  $\in$  per day (maximum 10 days, up to a 100  $\in$ ) if the driver is below 23 or above 70 years of age

# General terms of coverage

At vehicle pick up it is important to choose some type of extra coverage, there are ditterent coverage packages which are adjusted to your needs and abilities, from decreased damage excess to no excess at all.

Collision Damage Waiver limits the driver's responsibility for damages done to the vehicle. The customer is only responsible for the following amounts:

(a) 700,00 EUR (MBMR, MDMR) (b) 800.00 EUR (EWMR, EDMR, ECMR, EDMV, ECMV, EDAR, ECAR)

(c) 900.00 EUR (CDMR, CCMR, CDMV, CDAR, CCAR, IDMR) (d) 1.000,00 EUR (CFMR, CFAR)

(e) 1.350,00 EUR (IDAR, IWMR, IWAR)

(f) 1.400,00 EUR (SDAR, SWAR)

(g) 1.500.00 EUR (IFMR, IFAR, FVAR, SFAD) (h) 2.000,00 EUR (LVMR, LVAR)

(i) 2.200,00 EUR (PDAR, XCAR, LDAR)

(j) 4.000,00 EUR (PVAD)

The damage done to the vehicle will be charged according to the repair price list available

### Theft protection (TP)

Theft protection (TP) limits the driver's responsibility in cases of vehicle theft or damages done due to theft or attempted theft to the excess amount, which is subject to the terms of the rental agreement. TP does not cover personal belongings:

# Passenger coverage (PAI)

By paying an added daily passenger coverage fee, the driver and passengers are covered in cases of disability or death to the amount stated in current insurance regulations and rules. Risk and user responsibility can be limited to accepting the following

Super Collision Damage waiver plus reduces the damage excess to the following limits: 0€ for categories (Mini, Economy, Compact, Intermediate, Standard, Fullsize, Premium, Luxury and

Deposits with SCDW included are at least:

## Super Collision Damage Waiver (SCDW)

is coverage that reduces responsibility to 0 in case of damage to the vehicle body.

## WUG

Wheels, undercarriage and glass protection is complete coverage for damage done to the undercarriage, glass, and wheels of the vehicle.

## In case of a traffic accident, theft, engine breakdown or similar

The client is obliged to:

(1.) keep the vehicle safe until the time it is picked up by the lesson

(2.) take the names and addresses of every witness and participant

(3.) call the police and procure their record except in the case of motor breakdown

(4.) give a statement as soon as possible in the nearest office of the lessor (5.) In the case that the user does not procure a police report, all accepted coverages such as TP / CDW, CDW+ or SCDW are considered invalid due to the client's failure to comply with the provisions of the rental agreement and general terms and conditions.



## CREATING EXPERIENCES

### Costs that are not covered by CARWIZ and cannot be covered by any additional coverage

(1.) Loss or theft of luggage and or personal items from the vehicle

- (2.)Parking tickets or fines, traffic violations
- (3.) Costs due to the wrong fuel type usage (4.) Expenses for lost, stolen or damaged car keys
- (5.) Expenses for lost, stolen or
- damaged car documents
- (6.) Expenses due to negligence -

empty battery

- (7.) Expenses due to damage to the car's interior
- (8.) Costs of lost equipment (spare tire, tire repair kit, bunker shelves, document etui, driver's manual)

- (12.) Expenses to the vehicle under the influence of alcohol or drugs

- (18.) Costs created in cases when the main driver or additional driver stated in the rental contract does not have a valid driver's license or has a ban on driving motor

Other: damaged windscreen wipers or locks, loss or theft of outside parts of the vehicle without a police record, damage costs incurred by usage of roof carriers or luggage on carriers, damage caused by improper handling of luggage and or putting cargo or luggage on the roof, hood etc., as well as expenses caused by ignoring sound and visual warnings of the vehicle.

## **Delivery & Collection**

Delivery/Collection must be arranged during the reservation process.

## **During Opening Hours**

## Vehicle pick-up/drop-ott outside of working hours

If the client decides to pick-up or return the vehicle to a location different from the one stated in the reservation or the rental contract, an additional fee of  $20 \in$  will be applied along with the one-way rental fee.

## Additional equipment and services

## **Fuel options**

All vehicles are coming with a full tank and need to be returned with a full tank. If the client returns the vehicle with less fuel, he will be charged according to a valid price list. Refiling service will be applied.

### Cross border fee and terms

Cross-border fee will be charged 50€ per border. An additional green card fee of 50€ will be charged for driving to North Macedonia and Albania. (For any unauthorized border crossing a penalty of 1000€ will be charged) SCDW insurance is mandatory for crossing the border of Bosnia and Herzegovina

The client can pre-pay for the full tank of fuel and bring it back empty. Our price for this service is equal to the current commercial fuel price. If you choose this option, try to return the vehicle with an empty tank. We do not refund unused fuel.

## Refueling service

If the client hasn't pre-paid the full tank of fuel, and the vehicle is returned less than full, fuel ditterence will be charged according to the current price list (2€ per liter). Refueling service will be charged (15,00€).

### **Additional Driver**

The fee for an additional driver is 6€ per day (max 60€ per rent ).

A child seat is a legal obligation and needs to be used for children up to 12 years of age and 135 cm of height. Choose the seat that best fits child age:

Baby seat (0-18 kg) – 5 € per day (50 € max per rental) Child seat (15-36 kg) - 5 $\in$  per day (50,00  $\in$  max per rental) Booster seat (children height up to 135 cm) - 5 $\in$  per day (50,00  $\in$  max per rental)

If you decide to rent a navigation system with your vehicle, 5€/day fee will apply daily, but not more than 50 € per contract.

Damage handling fee - administration fee
If the lessee does not have any additional coverage package, and vehicle damage occurs, alongside the damage itself, an additional fee of 60.00€ will be applied.

In the case that the lessee has lost the car key, a fee of 400,00 € and more (depends on a vehicle model) will be applied

## Lost documentation or registration plates

In the case of lost or stolen vehicle documentation/ registration plates, a fee of 250.00 € will be applied.

The police report is mandatory.

## **Vehicle Cleaning**

In case the vehicle requires a special cleaning procedure after drop-ott (i.e. smell removal, animal hair, spillage of liquids), a minimum fee of 100.00 € will be charged.

## Don't smoke in vehicles

The penalty for smoking in the vehicle is 250,00 €.
